STREET SCENE INITIATIVE

REAR FOOTPATHS AND PLAY AREAS

A number of residents have made enquiries into shutting off the Council owned footpaths and play areas to the rear of properties around the Glamis Road and Kilmarnock Road area, with a view to incorporating it into rear gardens.

The concept of a relief road for our area has been around for many years and we support the principle to relieve pressure from the A1150 and A167. The feasibility work to date has outlined two potential routes, which are both being assessed. We have made it clear that our preferred option is Route A.

RAIL HERITAGE

The Council has made significant steps in the last month to capitalise on the town's unique history as the birthplace of the modern railway. Firstly, it has agreed a Tourism Strategy that places railway heritage at the heart of the Darlington Experience, coupled with Theatre and other attractions.

A Railway Heritage Steering Group has been formed to deliver the plan. This includes the three Councils through which the original line went, the new Tees Valley Combined Authority, Network Rail, Northern Rail, Virgin Trains, the A1 Trust, the National Railway Museum and the Friends of the Stockton and Darlington Railway.

The Councils have appointment Festivals and Events International to develop the 200th anniversary celebrations that will take place in 2025, the year that the Combined Authority is promoting the area for the City of Culture. Those plans should emerge next year.

The Councils have completed the audit of the historic track bed and with the help of the Friends of the Stockton and Darlington Railway are promoting the line as a Heritage Action Zone.

A1 Trust are progressing well it's construction of the new locomotive, The Prince of Wales, and have plans to build a further two engines. Access to the £5 note bridge has just been opened and restoration of Hope Town Carriage works has been completed.

There are other exciting proposals being developed that will be announced shortly. All together it is hoped that this will create more jobs and opportunities in the Borough for both local people and visitors to enjoy.
